## **Drop Off, Pick Up, and Bus Rider:**

Drop Off: Please have student at Reading Junior High School (8101 FM 762 Rd, Richmond, TX 77469) between 7:45AM – 8:15 AM. Students must enter at the front of the school where FBRC staff will meet them. Please look for FBRC staff with a Summer Explosion T-shirt or signage.

Pick Up: Please pick up your child at the front of Reading Junior High School between 3:15-3:30PM.

Bus Riders: Students will be able to ride LCISD summer school buses that pick up and drop off at your closest elementary school. Schedule is typically not available until the school year ends. Check [www.lcisd.org](http://www.lcisd.org) and search for summer transportation schedule.

## **Dress Code:**

Please use good judgment and wear shorts that are appropriate. Summer Explosion T-shirts will be provided and must be worn each day of camp. Please have your student follow their school dress code.

## **Behavior:**

Safety and proper behavior are very important especially while traveling with a group of students. Students are expected to follow rules of the school, bus, field trip locations, and camp staff.

## **Breakfast/Snack/Lunch:**

Breakfast, lunch and snacks will be provided by FBRC. If your child has special dietary restrictions, please note on health form so alternative options can be provided.

## **Remind Text:**

Remind is a mobile application that allows parents to receive real time reminders through text messages of camp start date and time or notifications of any changes that may occur.
